If your EAD has expired or will be expiring soon, you can submit a new Form I-765 and filing fee (unless a fee waiver has been requested and granted) to file for a renewal EAD. Do not file for a renewal EAD more than 180 days before your initial EAD expires.

Depending on the work situation, EAD type issued to applicants may vary. For example, I-140 EAD is issued to academic profession. You should check the eligibility category (question 16) in I-765 instruction to ensure you qualify for a work permit. Once an EAD is issued, the permit will specify the period of time the applicant can legally work for.

When the EAD is close to expiring, you must file a renewal within 180 days of its expiry. Depending on the type of visa you have, you can renew the EAD only one time or many times. What if the EAD Has Incorrect Information On It? If USCIS has issued your EAD but it has some incorrect information on it, you can file to have it corrected.
