The deepening arises from the need to study multiple actions and themes: to examine the background project of the Mostra d'Oltremare identified in the new studies, not only in the city debate on a suitable space for exhibitions to be preferably located to the west, but also in authorial preliminary solutions, until now unknown, which have conditioned the final conformation; to highlight the specificity of the single elements of the complex, the survived and the disappeared ones, without limiting the study to the best known and most celebrated cases, but also to the less investigated and difficult to interpret ones, without neglecting the open spaces and the green areas; to deepen also those architectures that cannot be interpreted in the line of modernity but equally emblematic of that phase, therefore worthy of preservation; not limiting attention to the heroic, albeit debatable, phase of the first foundation, but analyzing with the same acumen the subsequent ones, starting with the problematic reconstruction and redefinition of the post-war period; not stopping at the systematic reconnaissance of indirect sources that have not been investigated until now - from the many archives, not only on a city but also on a national scale, to the newspapers and the press of the time - but questioning the same material consistency of the buildings with a scientific method; finally, not focusing only on the past and on the history of the Exhibition and of the single architectures, but projecting it into the future by identifying the best strategies of recovery, restoration and preservation.

The development of a closed-loop cycle is a necessary condition so as to develop a circular economy model as an alternative to the linear model, in order to maintain the value of products and materials for as long as possible. For this motive, the definition of the value must be demonstrated for both the environment and the economy. The presence of these analyses should be associated with the social dimension and the human component. A strong cooperation between social and technical profiles is a new challenge for all researchers. End of life of products attract a lot of attention, and the final output could be the production of technologies suitable for managing this waste.

The principle of sustainability should be strictly connected with safety, since both aim to conserve resources: in the case of sustainability, the resources are typically thought of as environmental, while in the case of safety, the resources are basically human. In spite of this common ground, discussions on sustainability usually give insufficient attention to safety. In the last years the EU has made large investments to increase the energy efficiency of the existing building stock, paving the way for a low-carbon future; however, less effort has been made to enhance its seismic resilience. Therefore, the safety and, consequently, the sustainability of towns situated in earthquake-prone countries remain inadequate. In such countries, energy renovation actions should be combined with seismic retrofitting. However, a number of barriers considerably limit the real possibility of extensively undertaking combined retrofit actions, especially for multi-owner housing and high-rise buildings. These barriers are of different kinds: technical (e.g., unfeasibility and/or ineffectiveness of conventional retrofit solutions), financial (e.g., high renovation costs, insufficient incentives/subsidies), organizational (e.g., occupants' disruption and relocation, renovation consensus by condominium ownerships), and cultural/social (insufficient information and skills, lack of adequate policy measures for promoting renovation actions). This book aims to overcome these barriers and to bridge the gap between sustainability and safety, so to conserve both human and environmental resources.

The current Global Financial Stability Report (April 2016) finds that global financial stability risks have risen since the last report in October 2015. The new report finds that the outlook has deteriorated in advanced economies because of heightened uncertainty and setbacks to growth and confidence, while declines in oil and commodity prices and slower

growth have kept risks elevated in emerging markets. These developments have tightened financial conditions, reduced risk appetite, raised credit risks, and stymied balance sheet repair. A broad-based policy response is needed to secure financial stability. Advanced economies must deal with crisis legacy issues, emerging markets need to bolster their resilience to global headwinds, and the resilience of market liquidity should be enhanced. The report also examines financial spillovers from emerging market economies and finds that they have risen substantially. This implies that when assessing macro-financial conditions, policymakers may need to increasingly take into account economic developments in emerging market economies. Finally, the report assesses changes in the systemic importance of insurers, finding that across advanced economies the contribution of life insurers to systemic risk has increased in recent years. The results suggest that supervisors and regulators should take a more macroprudential approach to the sector.

L'evento, organizzato congiuntamente dalle tre principali università pubbliche di Roma Sapienza, Tor Vergata e Roma Tre, e dal CNR, è stato dedicato all'impatto sui servizi bibliotecari dei nuovi modelli di produzione, fruizione, diffusione e condivisione di contenuti scientifici e formativi, sostenuti e incentivati dall'evoluzione delle tecnologie digitali e del web: dall'open access alle piattaforme di e-publishing, dai learning environment ai social network della ricerca (ResearchGate, Academia.edu, Mendeley ecc.), in un contesto normativo italiano ed europeo (quello del copyright) in cui tuttavia gli utenti – gli studiosi e le istituzioni di ricerca – e le biblioteche, rischiano di essere dei soggetti deboli rispetto agli altri attori presenti. I bibliotecari dovranno sforzarsi di agire come gruppo di pressione verso i decisori politici, per trovare delle strade di soluzione alla crisi della comunicazione scientifica; in questo sforzo NILDE ha tra i suoi punti di forza la vivace e collaborativa comunità delle biblioteche, in continua espansione anche al di là dei confini nazionali, e la formidabile usabilità del software, sviluppato dal team di sviluppo in costante dialogo con i bibliotecari che operano sul campo, rappresentando ormai uno strumento essenziale per il reperimento di documenti nel mondo delle biblioteche.

Qual è il significato sotteso a ogni rappresentazione cartografica? Cosa si cela dietro un'immagine di città, di realtà territoriali e marittime? Qual è la finalità cui tende la carta geografica? Conoscenza finalizzata certamente al progetto, ma anche alla diagnostica, al monitoraggio del cantiere e al check up continuo dell'edificio nel tempo. Si esige dunque la possibilità e la capacità di gestire, in maniera visuale, relazionata e dinamica, una notevole massa di informazioni, peraltro fortemente eterogenea per caratteristiche proprie e per formati. Il programma di ricerca si propone di fornire un contributo innovativo in ordine alla definizione delle modalità organizzative e procedurali mirate alla costruzione di data base integrati, finalizzati alla documentazione, e alle azioni di tutela, conservazione e valorizzazione del patrimonio architettonico e urbano, nonché al loro utilizzo da parte degli Enti pubblici territoriali e di operatori tecnico-professionali. Il campo di indagine è lo specifico architettonico, nella sua relazione contestuale urbana, e la città storicizzata, nel suo insieme, quale risultato del processo storico di formazione e trasformazione sino all'attualità. I casi di studio sono individuati da ciascuna Unità di ricerca in riferimento al proprio territorio di ambito. Un significativo contributo su una tematica di permanente attualità, atteso che la emergenza del terremoto ha drammaticamente riproposto la carenza di conoscenza sistemica, organizzata e finalizzata, dei beni storico-architettonici presenti sul territorio.
