Medium- and heavy-duty trucks, motor coaches, and transit buses - collectively, "medium- and heavy-duty vehicles", or MHDVs - are used in every sector of the economy. The fuel consumption and greenhouse gas emissions of MHDVs have become a focus of legislative and regulatory action in the past few years. This study is a follow-on to the National Research Council's 2010 report, *Technologies and Approaches to Reducing the Fuel Consumption of Medium-and Heavy-Duty Vehicles*. That report provided a series of findings and recommendations on the development of regulations for reducing fuel consumption of MHDVs. On September 15, 2011, NHTSA and EPA finalized joint Phase I rules to establish a comprehensive Heavy-Duty National Program to reduce greenhouse gas emissions and fuel consumption for on-road medium- and heavy-duty vehicles. As NHTSA and EPA began working on a second round of standards, the National Academies issued another report, *Reducing the Fuel Consumption and Greenhouse Gas Emissions of Medium-and Heavy-Duty Vehicles, Phase Two: First Report*, providing recommendations for the Phase II standards. This third and final report focuses on a possible third phase of regulations to be promulgated by these agencies in the next decade. Unfortunately, college students are seldom exposed these ideas, and have to wait until they reach graduate school before they wonder if their learning experience may have been different. The goal is to make those ideas accessible here by translating the cumbersome, obscure, and turgid expression of these ideas into twenty-first century examples that are more applicable and meaningful for undergraduates and the educated public. It is argued that judgment must always be applied to matters of fact. That is to say, the fact is not the end of the story.
