It illustrates how such biases are not only common, but can be much more predictable once we recognise their origins and manifestations in policy arenas. It explores what constitutes 'good evidence for policy', as well as the 'good use of evidence' within policy processes, and considers how to build evidence-advisory institutions that embed key principles of both
