the recognition that they are likely to receive for their writing."

Markers of identity define human groups: who belongs and who is excluded. These markers are often overt – language, material culture, patterns of behaviour – and are carefully nurtured between generations; other times they can be invisible, intangible, or unconscious. Such markers of identity also travel, and can be curated, distilled, or reworked in new lands and in new cultural environments. It has always been thus: markers of identity are often central to the ties that bind dispersed, diasporic communities across lands and through time. This book brings together research that discusses a very wide range of scholarly approaches, periods, and places – from the Viking diaspora in the north Atlantic, and Anglo-Saxon treasure hoards, to what DNA can and cannot reveal about human identity, to modern, multicultural Martinique, East London, and urban Africa, and the effect of the absence of geopolitical identity, of statelessness, among the Roma and Palestinians – to better understand how markers of identity contribute to the impact of diasporas. By adopting Social Movement Theories (SMT) as a basic framework to analyze the 2011 uprisings in the Middle East, this book disentangles the role of alternative networks and other forms of political conflict with reference to the Egyptian case in mobilising and forming a potential revolutionary movement. A strong-willed, independent woman, Tima studied to be a hairdresser and had dreams of seeing the world. At twenty-two, she emigrated to Canada, but much of her family remained in Damascus. Life as a single mother and immigrant in a new country wasn’t always easy, and Tima recounts with heart-wrenching honesty the anguish of being torn between a new home and the world she’d left behind. As Tima struggled to adapt to

life in a new land, war overtook her homeland. Caught in the crosshairs of civil war, her family risked everything and fled their homes. Tima worked tirelessly to help them find safety, but their journey was far from easy. Thwarted by politics, hounded by violence, and separated by vast distances, the Kurdis encountered setbacks at every turn, but they never gave up hope. And when tragedy struck, Tima suddenly found herself thrust onto the world stage as an advocate for refugees everywhere, a role for which she had never prepared but that allowed her to give voice to those who didn't have an opportunity to speak for themselves. From the jasmine-scented neighbourhoods of Damascus before the war to the streets of Aleppo during it, to the refugee camps of Europe and the leafy suburbs of Vancouver, *The Boy on the Beach* is one family's story of love, loss, and the persistent search for safe harbour in a devastating time of war.

"Despite widespread scepticism in receiving societies, migrants often remain loyal to their former homeland and stay active in the politics there. "Beyond Dutch borders" is about such ties.
