

## Public Administration And The New Public Management

A New Synthesis in Public Administration sets out a theoretical framework that takes this new reality into account. It reveals how government forms part of a co-evolving system between people and society, where public results are a shared responsibility and citizens are respected as important creators of public value.

This book addresses salient current issues in public administration research. It seeks to suggest where future research may or indeed ought to be focussed. To advocate the future routes for the development of research, this book is divided into themes, with a clear overlap between different approaches. The book has contributions that will assist students of public administration/public sector management and public policy, especially new PhD students, but will also be a useful resource for more established researchers to understand the major emerging issues within the field.

State Management offers a comprehensive yet concise introduction to the new field of state management, presenting an analysis of basic questions within the theories of bureaucracy, policy-making, principal-agent modelling and policy networks. Focussing upon recent state transformation, it illuminates public sector reform strategies such as New Public Management as well as incorporation, tendering and bidding, decentralization, team production and privatization. This book argues that we should look upon the variety of models or approaches to public management or public administration as all belonging under "state management". The so-called "working state" in a well-ordered society involves government delivering services, paying for social security and respecting the rule of law. In this text, Jan-Erik Lane systematically examines the key approaches to the study of how government attempts to achieve these goals, discussing the pros and cons of alternative frameworks of analysis. How can public administration (P.A.) nudge government to govern fundamentally better in terms of policy? How critical is P.A. contemplation and nudges – prods, shoves or hammer blows - to government-in-context? In this book, David John Farmer argues that government-in-context refers to government-in-totality, to what governs even if not called government and to what constrains government action. Constricting contextual features are infiltration, exfiltration and post-truth, raising questions relating to democracy. Infiltration into government is the action of gaining access that benefits big corporations, their owners and billionaires; findings are that it also mal-nudges government action through such elements as big money, lobbying, tax breaks and embrace of the free market. Reacting to factors like growing income inequality, what is explained as exfiltration occurs for middle- and lower-income people. Post-truth is noted as the Oxford Dictionary's word of the year for 2016, describing people concerned less with truths than with opinions. The book analyzes three practical "hammer blow" and 18 "shove" nudges to contradict the mal-nudges. Beyond Public Administration will be of interest to P.A. scholars and graduate students, more specifically those interested in critical, normative, or interpretive scholarship focused on various aspects of P.A. theory, governance, and practical management.

"NS is a conceptual framework that resonates with practitioners, but it is also a tool that can be used to expand the range of options open to government and bring coherence to problem solving and decision making. In the hands of practitioners, NS was becoming a process of discovery to create solutions to problems of concern to society and produce results of increasing public value. Chapter 1 explores what is different about serving in the 21st century compared to the previous century. Periodically, changes come about that transform the world we live in, and in the process, transform the role of government. This chapter argues that we live in such a time. Chapter 2 posits that conventional thinking about public administration and current practices are insufficient to guide the actions and decisions of government in a world characterized by deep uncertainty. Chapter 3 introduces the NS Framework and its concepts. The

framework brings together the role played by government, multiple agents in society and citizens in a way that opens up a vast range of choices to government in its search for solutions to real life challenges. The framework offers a dynamic perspective of public administration where governments are able to learn, adapt to changing needs and circumstances, and co-evolve with society. Part II is an introduction to NS as an applied process of discovery. It describes the steps that public sector leaders have found most useful for discovering pathways to a better future. Chapter 4, 5, 6 and 7 present what has been learned from the practitioners who have used the NS Framework to lead public sector transformation initiatives. The NS Framework does not provide answers; it opens up new lines of inquiry and integrates findings in ways that generate coherent narratives of change. A number of consequences flow from a dynamic view of the role of government in society. This includes an adaptive view of the interaction between the public, private and civic spheres of life in society, a deeper appreciation of the importance of civic results and the role of citizens in building governable societies. The way we think about government or democratic governance influences the actions that will be taken for their improvement, and what results will be achieved. Part III poses difficult yet fundamental questions concerning how to re-conceptualise the responsibilities of the State in the 21st century. Chapter 8 broadens the conversation about public innovation. Chapter 9 reframes the discussion on public sector leadership, and Chapter 10 opens a conversation on the need to re-think, re-frame and re-invent the functioning of modern democratic societies. The book includes four case studies from four different countries that exemplify NS concepts in practice. Each of the cases highlights a dynamic process of discovery focussing on public purpose, building on the strength of others and empowering citizens as problem solvers. Appendix A examines the transformation of Singapore's prisons from correctional facilities to centres contributing to the successful reintegration of ex-offenders. Appendix B provides an example of leveraging to improve care to children with complex diseases in Canada. Appendix C explores how co-creation and co-production were used to respond to challenges facing elder care in Fredericia, Denmark. Appendix D provides an account of the Helsinki Cleaning Day initiative and how self-organisation with support from other actors, including the public sector, can spark new ways of doing things."--
