The only significant attempt to pass a law to aid refugees came in 1939, when Democratic Senator Robert Wagner of New York and Republican Congresswoman Edith Rogers of Massachusetts introduced legislation in both houses of Congress that would allow 20,000 German refugee children under the age of 14 into the country over two years outside of the immigration quotas.

The Definition of a "Refugee" Under U.S. law, a "refugee" is a person who is unable or unwilling to return to his or her home country because of a "well-founded fear of persecution" due to race, membership in a particular social group, political opinion, religion, or national origin.

Immigration and Refugee Law. The most fundamental principle of immigration law is that non-citizens do not have an unqualified right to enter or remain in Canada. However, Canada's Immigration and Refugee Protection Act ( IRPA) requires that the Act be construed and applied in a manner consistent with the Charter.
